### Notice under section 18(1)(a) of the United Nations (Financial Prohibitions, Arms Embargo and Travel Ban) Sanctions Act 2019

#### Addition of One Entry to the Sanctions List concerning Somalia

Notice is hereby given that on **18 February 2022**, the United Nations Security Council Committee pursuant to resolution **751 (1992) concerning Somalia approved the addition** of the entry specified below to its Sanctions List of Individuals and entities subject to the measures imposed by the Security Council and adopted under Chapter VII of the Charter of the United Nations.

Accordingly, the prohibitions, travel ban, and arms embargo under sections 23, 24, 35 and 36 of the United Nations (Financial Prohibitions, Arms Embargo and Travel Ban) Sanctions Act 2019 apply with immediate effect to the above entry.
